**SECTION ONE: Terms of Agreement**

1. The Borough hereby grants permission to the Sponsor to conduct this organized activity on (dates & times) \_\_\_\_\_
2. A payment of \_\_\_\_\_ must accompany this agreement for the above agreed upon event. Checks to be made payable to Borough of West Grove.
3. Monies are to be received within seven days after the date this agreement has been signed and are non-refundable. If monies are not received within seven days, this agreement is null and void.
4. The Sponsor agrees to clean up any debris or trash and to be responsible for repairs to Borough's property caused by any act of negligence or lack of due care by the Sponsor's participants, invitees, guests, agents, employees or other affiliated persons.
5. The Sponsor will provide any additional facilities or services, such as crowd & parking control and sanitary facilities as may be deemed necessary to adequately conduct the Sponsor's activity.

6. The Sponsor must comply with Ordinance No.2003-03, which provide regulations for use of the Borough's parks.
7. The Sponsor hereby releases and forever discharges the Borough, its agents and employees from any and all claims whatsoever, resulting from any and all bodily and personal injuries, damage to property and the consequences thereof, which might occur to or be sustained by the Sponsor or any other person, persons, or property from the conduct of the organized activities, the conditions of the property of the Borough or the actions or failure to act by the Borough, its agents or employees. And further, the Sponsor expressly stipulates and agrees and employees from any and all claims, whatsoever, for any and all injury or damage sustained by any person or property, at any time, as a consequence of the sponsor's activities or presence on the property of the Borough.
8. The Sponsor must supply a current certificate of insurance to the Borough prior to use of the fields.



***GUIDELINE STATEMENT***

The Borough of West Grove Parks and Recreation Tobacco-Free Policy, Young Lungs at Play, is designed to protect the health welfare and safety of our park patrons.

***POLICY STATEMENT***

The Borough of West Grove is committed to providing a high quality of living for all residents. Therefore, we believe that:

1. Tobacco product use in proximity of children, youth, and adults engaging in or watching recreational activities is unhealthy and detrimental to the health of others.
2. Tobacco products once consumed in public spaces are often discarded on the ground, thus posing a risk of ingestion to toddlers and causing a litter problem.
3. As parents, leaders, coaches and officials, we are thought of as role models, and the use of tobacco products around youth has a negative effect on their lifestyle choices.

***TOBACCO FREE FACILITIES***


The Borough of West Grove does not allow the use of tobacco products on Borough of West Grove's owned park land, park facilities, and open space.

***COMPLIANCE PROCEDURES***

The emphasis on enforcing the Tobacco-Free Park policy is through voluntary compliance:

1. Appropriate town owned park land, park facilities, open space or joint town/school district properties will post Young Lungs at Play signage.
2. The Borough of West Grove staff will meet with activity organizations and/or leaders or coaches to discuss the policy and to distribute flyers with the "Tobacco-Free" regulations.
3. The Borough of West Grove staff will make periodic observations of activity sites to monitor compliance and help to promote awareness of the tobacco-free policy.

**RESOLUTION NO. 2012-04**

**TOBACCO-FREE PARK AND PLAYGROUND RESOLUTION**

**THE BOROUGH OF WEST GROVE AGREES TO ADOPT THE FOLLOWING RESOLUTION TO CREATE TOBACCO-FREE ZONES AT LOCAL PARKS AND PLAYGROUNDS.**

**WHEREAS**, in Pennsylvania, more than 858,000 young people are exposed to tobacco smoke pollution every day and the US Surgeon General has stated that there is **NO SAFE LEVEL OF EXPOSURE**, whether indoors or outdoors, and that children's exposure to second-hand smoke causes increased risk of sudden infant death syndrome, lower respiratory infections, middle ear diseases, more severe asthma, respiratory symptoms and slowed lung growth and is responsible for the premature deaths of over 430,000 Americans each year from lung cancer, heart disease, respiratory illness and other diseases; and

**WHEREAS**, secondhand smoke is responsible for over 50,000 deaths among nonsmokers each year; and

**WHEREAS**, tobacco kills more Americans each year than alcohol, cocaine, heroin, homicide, and suicide, accidents, fire and AIDS combined; and

**WHEREAS**, 80% of smokers started smoking before the age of 18, and the average initiation age is 12 years old; and

**WHEREAS**, everyday an estimated 3,900 young people under the age of 18 try their first cigarette and one-third of these children will die prematurely from tobacco related illnesses; and

**WHEREAS**, to help role model non-smoking behavior to children and youth; to provide children, youth and their families with a safe, smoke-free environment;

**THEREFORE**, the Borough of West Grove, in the State of Pennsylvania resolves as follows:

That the areas of parks and playgrounds where children are present such as the picnic areas, sports and playing fields, parking lots located in the Memorial and Harmony Parks in the Borough of West Grove to be designated tobacco-free.

Appropriate signage will be posted designating tobacco-free areas.


The Borough of West Grove Community will be notified of this Resolution.

Violators will be immediately ejected from the Memorial and Harmony Parks.

This Resolution will be come effective on March 7, 2012.
