**Intergovernmental Cooperation Agreement with New Garden Township establishing a Regional Police Department under Authority of the Pennsylvania Intergovernmental Cooperation Act Ordinance No. 2016-01:** Mr. Prosser moved and Mr. Turkington seconded to adopt Ordinance No. 2016-01, which authorizes the Borough of West Grove to enter into an Intergovernmental Cooperation Agreement with New Garden Township establishing a Regional Police department under Authority of the Pennsylvania Intergovernmental Cooperation Act.

**Intergovernmental Cooperation Agreement establish a Regional Police Department:** Mr. Prosser moved and Mr. Turkington seconded to approve the Intergovernmental Cooperation Agreement establishing a Regional Police Department between the Township of New Garden and the Borough of West Grove.
