PUBLIC HEARING: Chester County Department of Community

Development Grant Application. President Turkington opened the Public Hearing to discuss the applications for funding through the Chester County Department of Community Development. The West Grove Borough Council would like to apply for approximately \$1.4 million dollars for Streetscape and Infrastructure improvements to replace the water main, service lines, curbing, sidewalks and road reconstruction on Hillside Avenue and to install the infrastructure including storm sewer, water lines, sewer lines and roadway for an approved subdivision to be built by Habitat for Humanity of 40 owner-occupied homes. President Turkington discussed the proposed projects at great length; and after inviting Borough Council and the public for input; President Turkington announced that the Public Hearing was concluded.
