Mrs. Kristin Proto presented results from a recent community survey that was conducted to gain feedback from both residents and non-residents of West Grove Borough on what they would like to see happening in the Borough. The top 3 responses for commercial establishments were more restaurants, a café or coffee shop and a brewer or pub. The top 4 responses for events were festivals, live music/concerts, outdoor movies and parades. 56.3% of the respondents were Borough Residents. Following the discussion President

Johnson appointed Mrs. Proto as the chair of the newly formed events committee. Mr. Dan O'Connell was appointed as a member of the committee as well. Visitors from Rigby's Home Décor presented the idea of having sidewalk sales and possibly partnering with local vineyards for future events. President Johnson requested that they keep the Borough Manager informed if they intend on proceeding with that idea.
