VISITORS:

Farley Fry, Borough Engineer, presented a breakdown of the current status of the Authority's Wastewater system. Farley broke down the chain of events from 2005 to current which included the extensive inflow and infiltration work that was completed in 2018-19. The research and analysis concluded that the Authority currently has 18 approved connections available. These will cover the first five Habitat for Humanity units that building permits were approved for in October 2019 as well as 3 miscellaneous lots in the Borough. Farley explained that the Borough is in a good position from the

perspective that our community is essentially built out after the Habitat project is completed and that we want your system to be at capacity, which essential we are. With continued I&I efforts we should have no issue gaining approval for the remainder of the connections necessary to fulfill the Habitat project.
