PUBLIC WORKS:

- Curbside leaf collection is in full swing
- Christmas Tree Collection will run through the end of January 2022
- Snow operations equipment and road salt is ready to go 0
- Wastewater Gate installation We are starting with the gate to get that replaced first. Once we complete the UV upgrade, we will be replacing the remainder of the fence that is in disrepair due to rusting and flood waters.
- The UV project has now been submitted to the DEP for approval. Once we have 0 approval from the DEP, we can move to the bidding state of the project.

PUBLIC SAFETY:

Lieutenant Joe Greenwalt provided an update on police operations. Reaccreditation will take place in June of 2023 and that reoccurs on a 3-year cycle. Lt. Greenwalt recently graduated from the FBI National Academy and was congratulated by members of Borough Council for his accomplishment.

COMPREHENSIVE PLAN UPDATE

Chester County Planning Commission offered a few recommendations that will be considered at the final Task Force meeting on January 11, 2022. Following that meeting the Comprehensive Plan will make a recommendation to Borough Council for adoption.
