# WEST GROVE BOROUGH COUNCIL -Meeting Notes

## October 4, 2023

The Regular Meeting of the West Grove Borough Council was held on Wednesday October 4, 2023. The meeting took place in the community room of the Municipal Building located at 117 Rosehill Avenue. The President, David Prosser called the meeting to order at 7:30 p.m.

#### **VISITORS:**

Members of the West Grove Fire Company presented their 2024 budget which equates to a 5% increase on the 2023 budget. Contributing factors include the need for increased EMS staffing to cover lost time due to the hospital closure and increasing operational costs.

#### **PUBLIC COMMENT:**

Resident Carol Black inquired about the possibility of adding sidewalks to Summit Avenue. Currently there are no sidewalks in many sections of Summit Avenue and many children live and travel the street. Manager McCummings explained some of the process

of how street scape planning, and projects are accomplished in the Borough. The first step in planning for this level of a project is to have our engineering firm create plans for the project. Those plans are then used to apply for grant funding for the project. Future discussion will need to take place to move the concept to the planning stages. Ms. Black also asked about the condition of 244 West Summit, the code official will be asked to review. Resident Molly Wood inquired about lead paint ordinances due to the age of the homes in the Borough. Research will need to be done.

# **FINANCE:**

The 2024 proposed budget was discussed. Budgeting for connection fees for the Habitat Development and collection of Local Service Tax by Keystone were discussed. Borough Council agreed to meet for a Budget work session on Wednesday October 18, 2023.

4<sup>th</sup> Quarter Water/Sewer Bills were mailed out to the community the week of September 25<sup>th</sup>.

# **ZONING OFFICER'S MONTHLY REPORT:**

No comments were made regarding the Zoning Officer's September Report.

# **PUBLIC WORKS:**

- Two of the telephone poles have been removed from the Willow Street parking area. The last one needs underground conduit removed before it can come out.
- The streetlight at the corner of South Hills Drive and Guernsey Road was knocked down by a motorist. The LED fixture is fine and once a replacement pole comes in it will go back up.
- Vehicle damage at Harmony Park is being repaired including replacement of the bench on the walking trail.
- Interviews of Public Works Candidates are ongoing with the last one scheduled for Monday 10/9/2023.

## **PUBLIC SAFETY:**

Lieutenant Joseph Versagli provided an update on the September police activity including parking and traffic violations. The Homecoming parade was discussed along with the upcoming Trick or Treating event. Lt. Versagli assured those in attendance that the PD will have flares in place prior to the event starting this year.
