## **FINANCE ISSUES:**

- Emergency Repairs Needed
  - o 2" Galvanized water line in Church Alley has a 3<sup>rd</sup> leak in less than 6 months. Fidelity has quoted \$32,200 to directionally bore a new line and the quote has been reviewed by Hanover Engineering. The current leak is entering the foundation of a home on Walnut Street.
  - O The water leak at the intersection of Guernsey Road and Willow Street is a valve that needs to be replaced. Public Works schedule with mowing and recycling will not allow us to schedule the repair. Fidelity quoted \$10,300 to replace the valve and repair the leak.
