ZONING OFFICER'S MONTHLY REPORT

PUBLIC WORKS

- Due to weather conditions, Trash and Recycling Collection will be pushed from Thursday 1/9 to Friday 1/10. Future collections will both take place on Thursday's.
- Water service leak on Walnut Street, service line going to the old hospital.

CONSTRUCTION PROJECT UPDATES

- Oakland Avenue Phase II Revitalization is complete up to final paving. East Penn Railroad is requiring us to do some additional drainage work around the railroad crossing as well. Final paving and markings will be completed in the spring.

- Prospect Avenue Sidewalk Extension has been placed on hold for the winter. There was miscommunication between the contractor and PennDOT regarding the start of the project. Due to anticipated temperatures PennDOT requested that the project be postponed until temperatures reach an acceptable level in the spring. Two areas of concern are the reduction of the length of depressed curb for Mr. Burdett's body shop and the removal of the center island on West Meadow Drive. Both were changes required by PennDOT when they issued the Highway Occupancy Permit. The Borough has appealed both situations and they are currently being reviewed by PennDOT.

- **Park Master Planning Project Update:**
 - Chester County Municipal Park & Trail Improvement Grant secured \$100,000
 - Notification received that our project has reached the appropriations committee through Representative Houlihan's office. We are one of 15 projects. – Was contacted by staff at Representative Houlihan's office and Community Project Funding was excluded from the last bill to keep the Federal Government open in December.
 - PA Statewide Gaming Fund Local Share Grant submitted on 11/26/2024
- **Comprehensive Plan Update**
 - Official Map and Historic Commission/Resource Mapping
- Wildcats Park Usage Agreement has been passed to them for their review – Wildcats paid the 2024 Park Usage Fee and has proposed a few wording changes.
