

## Chapter 346. Streets and Sidewalks

### Article I. Snow and Ice Removal

#### § 346-1. Timing and area of required removal.

The owner or owners and/or person or persons in possession (e.g., tenants) of real property on which a public sidewalk is located shall, within the first 12 hours of day light after snow, hail and/or ice has accumulated on the sidewalk, remove said snow, hail and/or ice from the sidewalk to the full length and width of the sidewalk on said property. For purposes of this regulation, when any parcel of land or lot fronts or abuts on a public sidewalk, such sidewalk shall be deemed to be on such parcel or lot, for the full length of such frontage.

#### § 346-2. Removal by Borough; costs.

Should snow, hail and/or ice not be removed from any sidewalk according to § 346-1 hereof, the Borough may remove same and the persons responsible for such removal, under § 346-1, shall pay the Borough's cost for such removal. If such persons do not pay said costs, the property may be liened and subjected to all the remedies for recovering municipal claims.

#### § 346-3. Violations and penalties.

Any person who shall fail to comply with § 346-1 hereof shall be subject to a fine or penalty which shall not be less than \$20 for the first violation, \$50 for the second violation and \$75 for the third and subsequent violations in any calendar year.

## Chapter 375. Vehicles and Traffic

### Article IV. Snow and Ice Emergency

#### § 375-32. Snow emergency highways.

The highways or portions thereof to which the provisions of this article shall be applicable during all periods of emergency declared as provided in the first section of the article:

## § 375-33. Violations and penalties.

[Amended at time of adoption of Code (see Ch. 1, General Provisions, Art. I)]

- A. At any time during a period of emergency declared as provided in the first section of this article, any person who shall park a vehicle anywhere upon or along any of the highways or portions thereof listed in § 375-32 of this article, shall be guilty of a violation of this article, and upon conviction thereof, shall be sentenced to pay a fine of \$25 and costs of prosecution. In addition, any police officer may order the removal of any vehicle violating this order as per the provisions of the Pennsylvania Vehicle Code, 75 Pa.C.S.A. § 3352(c)(4).
- B. Any person who shall operate a vehicle upon any highway or portion thereof listed in § 375-32 of this article, if such vehicle shall become stalled upon any of such streets during a period of emergency declared as provided in the first section of this article, if such stalling shall have been by reason of the failure to have such vehicle or tractor equipped with the equipment hereinabove prescribed, shall be guilty of violation of this article, and, upon conviction thereof, such person shall be sentenced to pay a fine of not more than \$25 and costs of prosecution.
